Question:

Under this Programme, the Auxiliary Medical Service stated that it would enhance the volunteers' operational efficiency and emergency preparedness for infectious disease pandemic; and also would provide paramedic training to cope with infectious disease prevention and control. In this connection, will the Government inform this Committee of: a) in the light of the current epidemic haze, the details of the work effectiveness on volunteers' operational efficiency and emergency preparedness, and the plans for strengthening related work in the future; and

b) the specific details, standards and training hours of paramedic training to be provided to cope with infectious disease prevention and control.

Reply:

- a) In response to the development of the "Coronavirus Disease 2019" epidemic, as of early March, the Auxiliary Medical Service (AMS) has deployed a total of about 100 bodies working in three shifts per day (including responsible duty officers at the quarantine centres, escort service and headquarters support staff) to participate in the work concerned. In respect of anti-epidemic work, specific measures implemented to enhance the AMS members' operational efficiency and emergency preparedness are as follows:
- Since the beginning of the epidemic, the AMS has organised briefing sessions (each lasting for 3 hours) twice a week which are aimed at allowing all members involved in the operation to familiarise themselves with emergency work for dealing with infectious diseases. Up till mid-March, more than 1 000 members have participated in such briefing sessions.
- The AMS organised two classes (each lasting for 6 hours) of infection control course in March 2020 at which doctors and nurses would update members on the epidemic situation, infection control measures and protective equipment. A total of 80 training places were provided in the two classes.

— At the same time, the AMS also disseminates information on the epidemic situation from time to time through the dedicated page of the online social media "Facebook", as well as the departmental online portal for all members' information.

The AMS constantly reviews the current epidemic situation to ensure that relevant measures can meet the anti-epidemic purpose. The AMS also continues to review the effectiveness of the measures, making necessary adjustment. After the epidemic, we will review our experiences of the anti-epidemic work and roll out improvement measures to enhance members' operational efficiency and work effectiveness.

b) New recruits will undergo elementary training courses that include 2-hour basic training on infection prevention and infectious diseases, so as to acquire knowledge of infectious diseases including influenza pandemics.

The 10-hour regular training which is organised monthly on a district basis also covers topics of infection control. The training will continue to be provided in 2020-21 according to the regular training schedule of each district, so as to deepen members' knowledge in infection control and infectious diseases.

The Health Protection Unit of the AMS also organises talks on infectious diseases / influenza every year to disseminate latest information on infectious diseases, thereby enabling members to get prepared for annual outbreaks of influenza or infectious diseases.

To enhance members' knowledge of infectious diseases, we publish feature articles on infectious diseases in our quarterly publication, entitled "Auxiliary Medical Service News".

Reply:

From October 2018 to September 2019, concerning the requests for information under the Code on Access to Information received by the Auxiliary Medical Service (AMS), there was only one case for which only some of the required information was provided. There was no case refused for providing information.

- 2. Regarding the above case for which only some of the required information was provided, the AMS refused to provide the applicant with the selection data concerning the recruitment of the Operations and Training Officer(s) according to Paragraph 2.9 "Management and operation of the public service" of the Code on Access to Information. As the nature of the case was not complicated, the decision on withholding some of the information was not made at the directorate level. The decision was made subject to the "harm or prejudice test", and the public interest in disclosure of such information did not outweigh any harm or prejudice that could result from disclosure.
- 3. The AMS did not receive any requests for review from 2015 to September 2019.
- 4. From 2016 to September 2019, the number of requests for which the information requested was provided within 10 days and 11 to 21 days from the date of the AMS's receipt of a written request were 4 and 2 respectively. Of these cases, there was only one request for information which was refused under the exemption provisions in Part 2 of the Code on Access to Information.
- 5. From 2016 to September 2019, there was no case in which information could not be provided within 21 days from date of receipt of a request.
- 6. From 2016 to September 2019, the AMS had not consulted the Privacy Commissioner for Personal Data on any case in which request for information was refused.

Reply:

- (1) In response to the epidemic situation, the main responsibilities of the Auxiliary Medical Service (AMS) are to render assistance at the medical posts of the Department of Health set up in the quarantine centres, and to provide escort services for persons under quarantine to and from the quarantine centres or their homes.
- (2) Since 23 January 2020, the AMS unremittingly deploys members in different positions to participate in the anti-epidemic operations each day.
- (3) Up till mid-March, the AMS deployed a total of about 100 persons working in three shifts per day including responsible duty officers at the quarantine centres, escort service and headquarters support staff involved in the operation.
- (4) Specific duties of the AMS members include providing escort services for persons under quarantine to and from the quarantine centres or their homes; and rendering assistance at the medical posts of the Department of Health set up in the quarantine centres by conducting body temperature checks and assessment of health conditions for the persons under quarantine.

(5) The health and safety of members is the prime concern of the AMS. We strive to ensure that all members on duty are equipped with adequate personal protective equipment such as caps, N95 masks, face shields, protective gowns, rubber gloves, etc.
